Housing Center Agency Helps War Workers

Pat MacDonnell, War Housing Center area manager, advises that the Torrance center has helped to find accommodations for 1572 war workers—1365 of this number with families—since establishment of the center April 13, 1943.

He added that the job in 1944 will be even more difficult in view of the declining vacancies and called for continued help from the many organizations which have cooperated in the past.

In addition to carrying on its "Share Your Home" campaign, the center has helped to provide for the conversion of existing properties into 43 units. It has cooperated with the regional office of the Housing Administration in processing applications for privately financed conversions and with the Home Owners' Loan Corporation in the leasing of properties for conversion with public funds.

MacDonnell says that 1478 privately financed units have been produced or are under construction, while the HOLC has leased properties which will produce 178 additional units, of which 145 are being completed and 33 are under construction.

MacDonnell stressed that every home provided for war workers has saved the critical materials, manpower and money which would have been needed for entirely new construction.

"Hence all organizations which have helped the War Housing Center in the manner stated know they have contributed to the war effort in a substantial way," the area manager concluded.
