BIRTHS OUTNUMBER DEATHS 3 TO 1 IN TORRANCE AREA

Births outnumbered deaths more than three to one in the Torrance Health District during the past year, according to an annual report made public by Dr. Henry C. Smiley, district health officer.
Babies born to residents of the district totaled 2,066, but in addition to this number 261 babies from outside health jurisdictions chose Torrance and vicinity for their life debuts. In establishing a death rate one-third below that for the country as a whole the Torrance area registered 688 deaths for the year.
Included in this district are Torrance, Gardena, Redondo Beach, Hermosa Beach, Manhattan Beach, Palos Verdes and surrounding unincorporated territory.
The report reveals that there were 2,272 cases of communica-

ble disease reported, measles leading the list, followed by mumps, chickenpox and syphilis. Local children received from the health department more than 5,000 immunizations against diphtheria, smallpox and whooping cough.
In controlling venereal disease the Torrance health center at 2300 Carson st. recorded almost 4,000 patient treatments while tuberculosis control accounted for 850 clinic visits. Children chalked up a record with more than 3,500 health consultations at the center, it was pointed out.
As the epidemic of animal rabies swept through the Southland during the past year, 63 rabid dogs were charged to the Torrance jurisdiction as of June 30. It was disclosed that during the same period 475 local people
