G. A. McCall Retires as P. E. Storekeeper

G. A. McCall, storekeeper at the local Pacific Electric shops for the past 24 years, was retired from active duty this month.

McCall had been in the employ of Pacific Electric for 42 years, having entered their service in 1902. His duties had been largely confined to those of storekeeper during the entire period of his service—first as yard storekeeper at Graham Yards in Los Angeles, then at the 7th and Alameda store which was destroyed by fire in 1919.

In 1920, McCall assumed charge of the company's principal store at Torrance shops, which position he held until his retirement.

Charles S. Stock, former Torrance resident, and storekeeper in charge of engineering and electrical department material at Torrance shop since 1920, assumes the position made vacant by McCall's retirement. Stock has been railroaded since 1905 when he entered the service of the Los Angeles-Redondo Railway Co. He was made storekeeper at Redondo in 1914 and later served in the same capacity at the Sherman Yards in West Hollywood.

Both McCall and Stock have made many friends in Torrance during their long association with Pacific Electric who will wish to extend congratulations and best wishes.

Eastman Repairs Ordnance at Battle Front

Pvt. Darrell C. Eastman, whose wife, Mrs. Lola Eastman, resides at 1735 Date st., is with the U. S. Supply Forces in France at a U. S. Army ordnance collecting point. Sometimes operating close behind the battle area the point receives all damaged fighting equipment that comes back from the front lines, repairing and maintaining thousands of combat vehicles, instruments, small arms, artillery and tanks every month.

Located in the wide open spaces of French fields, this collection battalion is supporting the advancing armies by keeping their equipment in tip-top condition for the liberation of Europe. Medium automotive and heavy tank and automotive maintenance companies along with field artillery and tire repair units are combining their efforts and operations.

As Master Sergeant Max Cooley, 32, son of Mr. Walter Cooley of 58 Snyder Terrace, Uniontown, Pa., said, "We are receiving all the damaged equipment here regardless of the condition and before it leaves it is as good as new. We feel our men are the best in the business and we have plenty of parts in stock to complete the work that has to be done."

As the abandoned equipment is evacuated from the fields and roadways to the control point of the collecting station it is inspected and assigned to the various units for repair. Since operating in France this battalion has serviced more than 15,000 items per month.

Working on a 24-hour schedule these men have kept the fighting arms of Uncle Sam's boys in full repair and have saved at least 90 per cent of all the equipment turned in to them.

MOBILE KITCHENS
Mobile kitchens of the British War Relief Society, financed by the War Chest, now are on the battlefields of France, serving our fighting forces. In addition to food and drink facilities, their equipment includes a library, radio set, phonograph and records, and sound film projector.

Editor Torrance Herald:
Have you registered? Will you vote? I ask you this because I believe that every American should exercise his or her right to vote in this coming election.

If you and the millions of other Americans like you fail to vote this country will not be what it stands for. Men will take office without popular vote and when this happens we are organizing the very thing we fight today, government in the hands of a few.

This is the best way I know how to explain it. A democracy is where the leader carries out the wishes of the people. A dictatorship is where the people carry out the wishes of their leader. As President Lincoln said at Gettysburg, we should have a "government of the people, by the people and for the people."

America is the only nation that has held a general election during wartime. But it is shameful to look at the American voting record. President Roosevelt said in a recent radio address that "in 1920 49% of the people who could vote failed to go to the polls. In 1940 it was about 20% more." In 1944 let's make it 100%.
