Tax Rebates Are Being Made

Those who have refunds still due must not deduct the amount from their 1944 taxes, he warned. Taxpayers must remit their 1944 taxes in full by March 15, he said.

I do not agree with your ideas on the matter. I wrote a letter to the Mayor and Council setting forth my ideas in brief on the matter.

I also wrote to the Department of the Engineer who I presumed to be the one in charge of city planning. I assumed that his was the department that you referred to in the editorial.

Jan. 13, 1945.
Department of Building Permits,
City of Torrance,
Gentlemen:

If the subject of this letter does not come within the province of your department, please pass it on to the department concerned.

The local newspaper is attacking one department of the city government for not allowing big wartime housing projects to be constructed in Torrance.

They are particularly advocating the permitting of them in North Torrance.

I reside in North Torrance and own property there. We do not want city housing projects there. The one north of Redondo Beach Blvd., is already too close.

This district is zoned for agriculture and we want it kept that way. Please stand out against this encroachment on our district which will ruin the attractiveness of the same.

When the war is over these housing projects are going to present a real problem. Rents will be very low. A very undesirable element will move into them. Then you will have many problems, including that of po-

lice protection. The police of Torrance are so far away that they cannot furnish the protection that we will need. Crops, farm animals, poultry will all need to have protection from forays by thieves. And Torrance can't give such protection away out there.

You are to be congratulated for having kept the federal housing projects out of Torrance. Keep the privately-constructed ones out also.

That will be a real foresight for the benefit of the future.
