SEALED PROPOSALS will be received at the office of the City Clerk, City Hall, Torrance, California, until 8:00 o'clock p.m., on June 26th, 1945, at which time they will be publicly opened and read, for performing work as follows:

Furnishing all labor, transportation, materials, scaffolding, tools and equipment necessary for the construction of a recreation building 20ft. x 42ft. as per the plans and specifications. No bid will be accepted unless it is made on a proposal form furnished by the City Engineer. Each bid must be accompanied by cash, certified or cashier's check, or bidder's bond, made payable to the City of Torrance for an amount equal to at least ten (10) per cent of the amount bid; such guaranty to be forfeited should the bidder to whom the contract is awarded fail to enter into the contract.

In accordance with the provisions of Section 1770 of the Labor Code, the City Council has ascertained the general prevailing scale of wages applicable to the work to be done, as follows:

May be employed in conformity with Section 177.5 of the California Labor Code.

Sundays and Holidays: (except Watchmen, Guards, and Flagmen) One and one-half (1 1/2) times the above rates. Overtime: One and one-half (1 1/2) times the above rates. All bids are to be compared on the basis of the City Engineer's estimate of work to be done.

No bid will be accepted from a contractor who has not been licensed in accordance with the provisions of Chapter 791, Statutes of 1929, as amended. Plans, specifications, forms of proposal, and contract, may be obtained in the office of the City Engineer, City Hall, Torrance, California, upon payment of \$1.00; refundable upon return in good condition.

The City Council reserves the right to reject any or all bids, or any item or items of any bid, and to take all bids under advisement for a period of not to exceed thirty (30) days after date of opening thereof.
