Weekday Church Schools Will Be Extended

With the recent re-election of John W. Yates as president of the Church Federation of Los Angeles, plans have been revealed for an expanded program of released time religious instruction for public school pupils.

Yates, prominent Methodist layman and insurance company executive, now serving his second year as president of the inter-denominational body, stated that the Church Federation hopes to operate Weekday Church Schools for pupils of 100 elementary schools and ten junior high schools during the coming school year. Last year, he said, the Federation served 56 elementary schools.

The entire program of released time religious education, in which Jewish and Catholic groups are also participating, is undertaken in cooperation with the Los Angeles City Board of Education. Public school pupils are released for 40 minutes each week to attend the church schools, which are located near public school premises. Written consent of their parents, however, is requisite to attendance.

Yates also stated that the Federation will continue its Youth Project work and counseling service for youth, both of which are supported by War Chest funds, as well as its community educational program in behalf of Christian race relations and world order.

Lesson—"Life" in all branches of The Mother Church. The First Church of Christ, Scientist, in Boston, is from Luke and reads, "Now that the dead are raised, even Moses showed at the bush, when he called the Lord the God of Abraham, and the God of Isaac, and the God of Jacob. For he is not a God of the dead, but of the living; for all live unto him." The Lesson-Sermon includes this selection from Mark: "Jesus took with him Peter, and James, and John, and leadeth them up into a high mountain apart by themselves; and he was transfigured before them. . . . And there appeared unto them Elias with Moses; and they were talking with Jesus. And Peter . . . said to Jesus, Master, it is good for us to be here: . . . The center is especially adapted to accommodate uniformed servicemen and women of all rank and denomination who have but a few hours between trains, with a restful place where they may visit with relatives and friends in a private and quiet atmosphere unobtainable in the crowded railway and bus stations.

Its location directly opposite the Union Station will be of growing usefulness as more and more troops pass through the city on their way to and from the Pacific battle stations.
