Los Angeles Schools Break Down and Decide to Enlarge Fern Ave. Plant

According to word from Los Angeles, the Los Angeles city school district is planning to erect a four-unit classroom building at Fern Avenue school to cost \$25,000.

The building is the second planned here, one at the high school, of temporary nature, to cost \$7500, now being in the hands of the contractor.

The two buildings total \$32,500 in value, and amount to about one-tenth of the overpayment which Torrance makes annually to the Los Angeles schools.

This year, Los Angeles will get in excess of \$600,000 and will spend only about half that amount here.

Torrance could have a \$300,000 school plant built here, bond and cost free, annually if the money it pays to Los Angeles over and above costs of operating the schools were to be spent here.

Of course, the cost of operation would go up with the addition of, say a new and separate high school, or a new junior high school, or needed vocational and industrial education facilities, new and modern gymnasiums and improved athletic facilities, or new elementary schools, but Torrance would be glad to pay if she was getting \$1.00 worth of value for each \$1.00 spent. But when Torrance gets only 50 cents on the \$1.00 spent, she has reason to complain.

This is the cause of action of Torrance Parents' Association in its attempt to withdraw Torrance schools from Los Angeles control and operation.

RETURN HELMETS

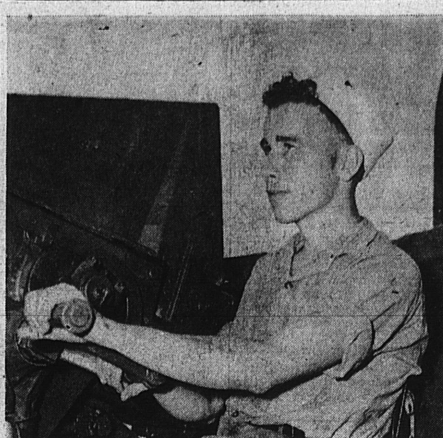
