Occupant Of Trailer Faces Police Action

Trailer dwellers who take advantage of the kindness of the City Council of Torrance will be dealt with harshly, it was decided Tuesday night.

City Engineer G. M. Jain reported that one trailer occupant, in Waleria, had lived in his trailer for two years. He asked the City Council in January, when he was requested to remove his trailer home, to grant him 90 days in which time he would build a house.

He still has not moved, Jain said, and he asked for police action, which was ordered. Jain said the occupant even had removed the wheels from the trailer, also against the law in Torrance.

BEACH FRONTAGE PURCHASE WILL BE PUSHED BY STATE AND COUNTY, SAYS DARBY

Beach frontage extending northerly from Torrance Beach to a point above Santa Monica soon will be acquired from private sources for public use under a joint purchase program between the Board of Supervisors and the State Park Commission.

This information was made public by Supervisor Raymond V. Darby, who stated conferences with Col. Raymond C. Kelton, engineer of the State Park Board, have developed to the point where appraisers are about to be named for the desired frontage.

Darby said that while the county listed beach land valued at \$10,423,740.00 on the county's No. 1 priority list for acquisition on a matching basis with the state, Colonel Kelton informed the supervisors that the state cannot consider Los Angeles county purchases of more than from \$3,500,000 to \$4,000,000 out of \$10,000,000 available for state-wide use.

Under the circumstances, the county will revise its list of most purchases in order the most seriously needed beach strand can be converted into public ownership as soon as possible.

The Torrance strand has been listed in "Priority No. 1" due to its value to the Redondo Beach shoreline rehabilitation program, Darby explained recently at a Torrance meeting. Sand from the bluff and areas above Torrance beach will be used in rebuilding and widening the beach from the Torrance city line to and including the badly depleted Redondo Beach strand.

Waleria Water Petitions Far Exceed Need

While the law requires only 10 percent of the registered vote to sign petitions for forming a water district, petitions in circulation in Southwest Torrance and the Waleria district already contain more than 50 percent of the total registration, according to George P. Thatcher, who is in charge of circulation of the petitions.

They will be checked tomorrow by City Clerk A. H. Bartlett, and will be submitted to the City Council at its next meeting at which time the election to vote bonds to finance the water district will be called.

Within the area are all portions of Southwest Torrance from Crenshaw blvd., west to the east boundary of Hollywood Riviera, and all territory south of Sepulveda blvd., to the city line.

Thatcher said that as soon as the petitions are filed and the election called, the City Council will be asked to order a survey made of the same territory to determine the need for and cost of sanitary sewers, and ability of the property involved to stand the additional bonded indebtedness necessary to finance the sewers.

Waleria Civic Association Wants Crowther

Waleria Civic Association, through Bessie Stonecker, secretary, Tuesday night asked the City Council to appoint on the City Planning Commission J. W. Crowther. In a letter read at the meeting, the association praised his work.

Councilman C. M. Gilbert said that Crowther had been unable to attend meetings and he requested that before taking any action the planner be asked whether or not he can be active on the board. The matter was held over for later action. Crowther no longer resides in Waleria and George P. Thatcher, of the Waleria Community Council, at a previous meeting had asked that a Waleria resident be appointed to the board.
