## Darby Endorses Torrance Army Hospital Conversion Suggestion

Supervisor Raymond V. Darby has personally endorsed the idea that Torrance Army hospital be converted into a branch of County General hospital after the U. S. Army abandons the institution, he informed Harry B. Lewis, president of Torrance Lions club, this week.

The Lions club, acting on the suggestion of the county charities department that a survey be made of possible locations for branch hospitals, had suggested to Darby that the army hospital be converted into a branch county hospital to serve the entire harbor area.

"I think you have a good suggestion," Darby told Lewis, and "it seems to have a lot of possibilities."

Darby said that he had asked Arthur J. Will, superintendent of charities of Los Angeles county to investigate the matter, and likewise requested A. H. Campion, acting chief administrative officer, to consider it in the survey of needed county hospital facilities throughout the unincorporated area.
