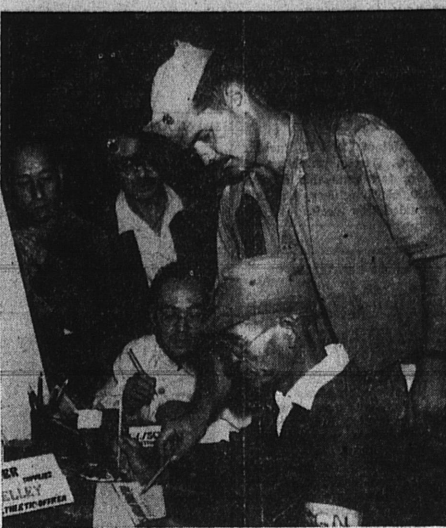

James G. Shidler, Lone Marine, Five Japs Operate Sign Shop

Operated by one Marine and five Japs, the sign shop at Second Marine Division headquarters here has produced an estimated 5000 signs since the Leathernecks began the occupation of Nagasaki, Japan.

The lone Marine in charge of the shop is Pfc. James G. Shidler, 28, of 1310 Manuel ave., Torrance, Calif. A former aeronautical engineer, Shidler entered the service Sept. 3, 1943.

"I had never painted a sign in my life before we landed here," Shidler said, "but we needed a sign shop, and I was elected. I found a place to work, but I didn't have any materials. I had to beg, borrow and steal everything I needed."

The demand for signs in Nagasaki has been tremendous, there were, of course, no English signs on the scene when the Marines arrived. Buildings, offices, yards, streets and work shops all had to be identified. Orders for directional signs.
