

Local Suicide Leaves \$15,000 To Red Cross

Adrian T. Stevenson, 58, who police say took his own life with a .32 caliber revolver in his home at 1229 Portola ave. last week, leaving three notes explaining his actions knifed to the walls, left the bulk of his estate estimated at \$15,000 to the Torrance chapter of the American Red Cross, according to his attorney, Charles T. Rippey.

Police entered Stevenson's home after neighbors reported they were unable to get any response from their repeated knockings.

His body was found by the police, seated upright in a chair of an overheated room, with the revolver still in his hand.

One of the notes left, read in part: "I am at limit of endurance." In another he wrote: "... have Rev. Roloff say a prayer... my life has been mismanaged for the past five years. God have mercy on my soul and please take care of Ma and Pa. I am in hell on earth, kidney and heart trouble." Both of his parents are dead.

Stevenson, a resident of Torrance for many years, was divorced from Mrs. L. Stevenson, to whom he was married only a short time, according to reports. Mrs. Stevenson is now living in Washington. Rippey said that apparently there were no other survivors.
