Passage, with min ing amendments, of a any amendments, of a Torrance smog control ordinance as drafted by the city attorney's office, was urged on the city council at Tuesday night's meet-ing in a Chamber of Commerce resolution

ing in a Chamber of Coninerce resolution. The proposed regulation dif-fers from the county's "model" ordinance chiefly in that it would permit dense smoke for a pet-lod of seven minutes per hour instead of the county's three. Penaity for violation would range from a low of \$5 to a high of \$200, with each new day's violation constituting a new offense. However, provision is made for variances and waiv-ing of requirements in the event of conditions beyond control of the offender, providing such beyond control of er, providing such applied for in ad.

Administration and enforce-ment would be in the hands of the director of Air Pollution Con-trol, provided for in the County According to the act, erson is guilty, of a heanor who, either by, i

scoreing to the act, "Every person is guilty, of a misde-manor' who either by himself, its auguous of zery, arough source whatsoever, any smoke, dust, soot or fumes (of a sti-pulated density) for periods ag-gregating more than seven min-utes in any one hou." It also declares guilt of any person who "permits to be dis-charged from any source what soever such quantities of charred paper, smoke, dust, soot, grine, carbon, noxious acids, fumes....or injury, detriment, nuisance injury, detriment, nuisance indury, detriment, nuisance indury, detriment, and any persons..." The council has submitted the measure for comment to the various industrial plants affected before taking action.


