

BECAUSE—The City Council on advice of the Insurance Underwriters, will use City Property, already owned and paid for—at El Prado and Cravens—for the new central Fire Station.

BECAUSE—By so doing, funds can be made available to take care of our neighbors in North Torrance, who shortly, with installation of wate mains there, and with home development assured, must be given fire protection.

BECAUSE—Since the earthquake in 1941— nothing has been done to put the old (nov condemned) fire station in a safe condition.

BECAUSE—The Wateria-South Torrance District, needs have been carefully considered—a \$24, 000 new Fire Sub-Station in this district is included in the bond issue, and adequate plans for protection have been made for the future.

BECAUSE—Torrance, which shortly becomes directly responsible for the welfare and safety of our school children, must provide better pro-tection for school children and school buildings.
