Most of the World War II veterans' benefit laws carry a deadline, or date, after which the benefits of the lows are denied unless extensions are made by act of Congress.

For example, the Servicemen's Readjustment Act (G.I. Bill) with its school, on-the-job training, readjustment allowance and loan benefits, sets time limits on its provisions. Veterans applying for compensation have a decided advantage in establishing service connection if application is made a year after separation from service. Veterans in order to secure terminal leave pay must apply before Sept. 1, 1947, is the next deadline on certain valuable G.I. benefits. After that date some of the liberalized features of the amended National Service Life Insurance Act will ecase to exist unless prolonged again by Congressional law.

1. Until that date veterans of World War II who have allowed their NSLI policies to lapse may reinstate upon a "comparative health" basis. This means that those who are able to sign the statement that they are in as good health now as at time of lapse need not take a physical examination. The whole transaction of reinstatement takes no more than 15 minutes' time if done on this basis.
