Health Officer Says Rabies Death Needless

Under California State laws, all animal bites of human beings in this area should be reported to the Torrance Health Center, 2300 Carson street, according to Dr. Roy O. Gilbert, Torrance County Health officer.

Dr. Gilbert stated that the first death by rabies in Los Angeles county in four years might have been averted if a dog bite had been promptly reported, and anti-rabies treatment instituted.

No report was made to the County Health department of the bite, which laboratory tests and post mortem showed was the cause of the recent death of Kenneth Gates, of Moneta. The injury and queer actions of the dog occurred six weeks before the deceased showed symptoms of the disease.
