Resumption of receipt of applications under Title VI of the National Housing Act, from approved lending institutions as of January 2, 1948, was announced today by John E. McGovern, director, Southern California District, Federal Housing Administration.

At the time that legislation was passed a definite limit was set by Congress as to the dollar volume of loans which the FHA could insure. That amount was exhausted in November of this year, and on Dec. 27 the President signed a new bill authorizing an increase of \$250,000,000 with authority in the President to further increase the authorization by \$500,000,000 for Title VI insurance.
