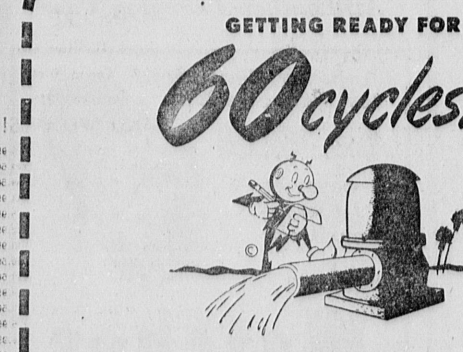
Goodyear Starts 2nd Round With Win Over Harvey

Felker's rightfielder, M. Schmidt, smacked a four ply blow in the second contest. The winners stacking up 9 of their 15 runs in the initial inning...

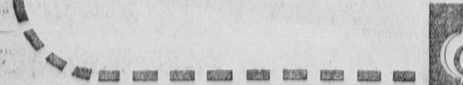
