Torrance-Lomita Realty Board Urges Port Site for Hospital

Torrance realtors have joined the fight to have the projected Naval Hospital planned for this area put in the San Pedro hills.

At a meeting of the board of directors of the Torrance-Lomita Realty Board last Friday, members voted to join with San Pedro's urging that the San Pedro hills be chosen for the new naval installation.

In voting the recommendation, board members pointed out that such a location could enable the hospital facilities to be used by both the Army and Navy, including the Fort MacArthur cases.

"It is interesting to note that the Navy already owns the property between Gaffey and Western and Palos Verdes drive, North," C. J. "Paddy" Ryan, president of the board, said this week.

"We feel that this will be worth working for," he said. The Torrance-Lomita group addressed letters to the Chambers of Commerce in the area, to local newspapers, and sent a night letter to Representative

Cecil King in Washington.

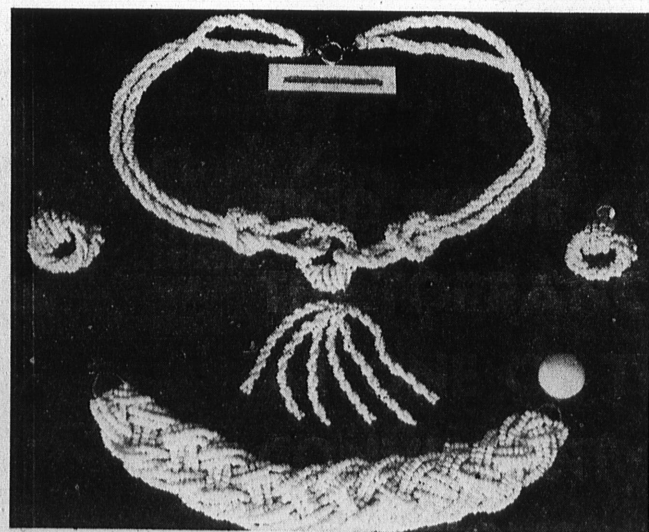
