

Billfold in Pocket Saves Soldier's Leg

Carrying his billfold in his hip pocket is one habit which Lt. Marvin A. "Lonnie" Lee is probably glad he formed. The billfold probably saved his left leg when he was wounded on a Korean battlefield recently.

The son of Mrs. Olive Lee Wittenberg, of 1228 Arlington avenue, Lieutenant Lee is now recovering in an Army hospital in Osaka, Japan. He was wounded June 4 while fighting above the 38th Parallel. A Chinese Red machine gunner opened fire on him, hitting him in the hip. Doctors credit the billfold—which took the impact of the shots—with saving his leg.

Lee, whose wife and two sons live in Van Nuys, was teaching at Gardena High School when recalled to active duty in October, 1950. A graduate of Torrance High, he was born in Torrance and spent most of his life here.

NOT FIRST TIME

A tour of duty in an Army hospital as the result of enemy action is no new experience for Lieutenant Lee. The 29-year-old lieutenant was wounded during World War II, when a German land mine exploded in Northern Germany, according to his mother. He spent several months in the hospital following that injury.

Lee writes that he is receiving "good care" in the hospital in Japan and that he is doing fine. He told his mother that it was three hours before he was returned to an aid station after he was wounded, and then it was two days before he could be moved out. A helicopter flew him to the rear lines, then he was taken to Japan, he wrote.

YES, EVEN A DOLLAR WILL HELP--A LOT!

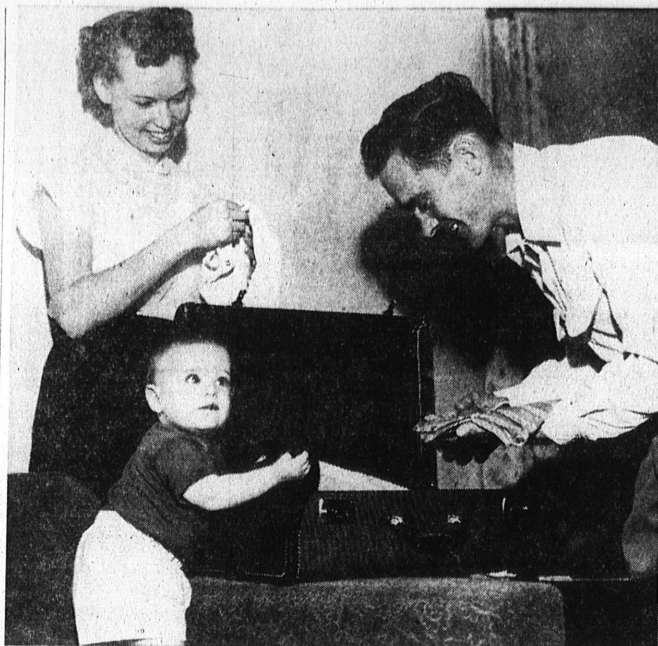

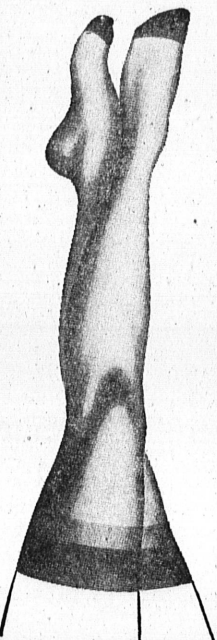

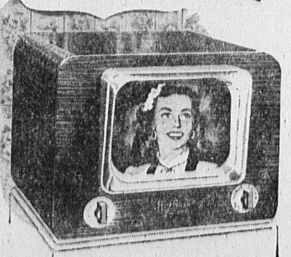
