NOTICE OF SCHOOL BOND ELECTION
 NOTICE IS HEREBY GIVEN to the qualified electors of the Torrance Unified School District of Los Angeles County, California, that in accordance with the provisions of the Education Code of the State of California, an election will be held on the 7th day of June, 1955 at the polling places named in the heretofore described precincts in this School District, between the hours of 7:00 a.m. and 7:00 p.m. (during which period and between which hours the polls shall remain open), at which election the question of issuing and selling bonds of said District to the amount of TEN MILLION DOLLARS (\$10,000,000.00) for the purpose of raising money for the purchasing of school lots, the building or purchasing of school buildings, the making of alterations or additions to the school buildings or buildings other than such as may be necessary for current maintenance, operation or repair, the repairing, reconstructing or rebuilding of any school building damaged, injured, or destroyed by fire or other public calamity; the supplying of school buildings with furniture or necessary apparatus of a permanent nature; the permanent improvement of the school grounds; the carrying out of the projects or purposes authorized in Section 18010 of the Education Code, shall be submitted to the qualified electors of said District and be voted upon, and that all said purposes shall be united and voted upon as one single proposition.
 The said bonds proposed to be issued and sold shall bear interest at a rate not to exceed five per cent per annum. The interest for the first year shall be payable in one installment at the end of said year and all interest thereafter shall be payable semiannually. The number of years said bonds, from the date thereof or the date of such series thereof, shall not exceed twenty-five (25) years.
 That, for the purpose of holding said election, the said Torrance Unified School District shall be and it is hereby divided into fifteen bond election precincts, designated bond election precinct numbers 1 to 15, in accordance with the annex hereto annexed, being complete and qualified electors of this School District and of their respective bond election precincts, are hereby appointed officers of election, inspectors and judges respectively, as heretofore set forth, and said officers shall conduct said election and make return therefor pursuant to law.
