

NOTICE OF SALE OF BONDS

Notice is hereby given that sealed proposals will be received up to 4 o'clock a.m., California Daylight Saving Time, of June 7, 1955, by the Board of Supervisors of the County of Los Angeles, State of California, in its office at Room 501, Hall of Records, in the City of Los Angeles, for the purchase of the following described bonds of Torrance Unified School District of the par value of One Million Six Hundred Thousand Dollars (\$1,600,000.00). Each of said bonds will be dated July 1, 1955, and will bear interest at a rate not to exceed five per cent (5%) per annum, which shall be in multiples of one-fourth (1/4) of one per cent (1%), which rate of interest shall be determined upon the sale. The interest for the first year shall be payable in one installment at the end of said year, and all interest thereafter shall be payable semiannually, both principal and interest to be payable in lawful money of the United States, at the Treasury of the County of Los Angeles, or at any of the fiscal agencies of the County of Los Angeles in the City of New York, State of New York, or in the City of Chicago, State of Illinois, at the option of the holder. Said bonds will be designated "Election 1954, Series B".

The bonds herein referred to for the purpose of raising money for the purchasing of school lots; the building or purchasing of any school building damaged, injured, or destroyed by fire or other public calamity; the supplying of school buildings with furniture or necessary apparatus of a permanent nature; the permanent improvement of the school grounds; the carrying out of the projects or purposes authorized in Section 16101 of the Education Code.

Torrance Unified School District has been acting as a unified school district under the laws of the State of California continuously since January 24, 1947.

The assessed valuation of the taxable property in said unified school district for the fiscal year 1954-55 is \$24,800,000.00, and the amount of bonds previously issued and outstanding as of May 3, 1955, is \$8,500,000.00. The percentage of tax delinquency for Torrance Unified School District for the last five years is as follows:

Torrance Unified School District includes an area of approximately 13.88 square miles, and the estimated population of said unified school district is 47,825.

The bonds will be sold for each only and at not less than par and accrued interest.

Each bid must state that the bidder offers par and accrued interest to the date of delivery and state separately the premium, if any, and the rate of interest offered for the bonds bid.

Each bid shall be for the entire amount of said bonds at a single rate of interest, and any bid for less than the entire amount of said bonds or for varying rates of interest will be rejected.

Payment for and delivery of bonds will be made in the office of the Board of Supervisors.

A certified or cashier's check for a sum not less than 5% of the amount of the bonds bid for payable to the order of the Chairman of the Board of Supervisors, must accompany every bid as a guaranty that the bidder, if successful, will accept and pay for the bonds described in the accepted bid in accordance with the terms of his bid, and said check shall remain in the possession of the Board of Supervisors until all said bonds are paid for. The Board reserves the right to reject any and all bids. The Board also reserves the right to disregard insubstantial irregularities and technical defects in bids.

At the time of payment for and delivery of the bonds the County will furnish the buyer or its agent a certificate that there is no litigation pending affecting the validity of the bonds.
