

Service Unit Addition Bid Receives OK

The Hann Construction Co. of Compton was awarded the bid for construction of a service unit addition for the Torrance Unified School District at 2330 Plaza del Amo, by the Board of Education at an adjourned meeting last week.

The firm submitted a low bid of \$173,800. The building will be used for offices and storage.

The board also approved a topographical survey to be made before start of construction work on Edison School, to be located at 182nd and E. 4th Ave. Completion of estrow requirements on the site also was approved.

The resignation of Dr. Rollin R. Smith was accepted, "with regrets," since he is leaving the city. Another board member and a new president must be selected by the board, probably at the next meeting.
