Incorporation promoters in
Lomita have published the
names of people who, they
claim, want property owners
to sign a petition for incorporation.
Of these people, 21 per
cent do not live in Lomita at
all and could not vote here.
Another 34 per cent are
not listed in the phone book
and there is doubt as to their
places of residence.
Of the 45 per cent who are
known residents of Lomita,
some have denied that they

authorized use of their names. This is a sample of methods being used by promoters to herd Lomita property owners into incorporation.

The law gives property owners the right to decide, for their own protection, whether to have an election or not. This is proper, because a majority of Lomita residents of votting age do not own any real property and pay no real property taxes, but can vote in any election like all other registered voters. They can out-vote property owners who would have to pay the expense of city government through increased taxation.

Property owners should be permitted to make their decisions without interference from outsiders and persons who are not Lomita Drive League condemns these tactics on the part of incorporation promoters.

help within four minutes.

City honors. The taxpayer

with.
