


City Council A survey of what Torranci teeds in recreational facilitie will be started within two reeks, according to Recre

The study of possible park sites and needed recreational facilities will be made by Louis J. Kroeger and Associ-ates, planning consultant who was hired by action of the City Council Tuesday night. Cost of the survey will be \$26250.

Cost of the survey will be \$6250. The survey is expected to be completed by next Janu-ary. Van Bellehem indicated. Points to be covered by the Kroeger firm include recom-mendations on: 1. Location, type, and gen-eral description of needed rec-reational facilities. 2. A priority system for ac-quisition and development of new recreational sites over a reasonable period of time. 3. Přobable costs to the city, with suggested alternative ways of meeting the cost effi-ciently and economically. The firm will work closely with city officials in analyzing such factors as probable fu-ture growth of the population, zoning; geography, street sys-tems, present recreational fa-cilities (both city and private), and groups who would be using future facilities.
