Poultry Ranches of Area To Be Judged Here Today

Judging of the Poultry Ranch Merit Award program for 1957, sponsorcd by the Poultry Department of Los Angeles County Farm Bureau, will take place today, according to Ken Christofferson, this year's, chairman of the Ranch Merit Award committee.

The program, initiated three years ago by the Farm Bureau Poultry Department; is designed to aid in the beautification of local ranches; to improve local ranch santiation, and to improve the poultryman's public relations with his city neighbors. Chairman Christofferson pointed out that many of the local poultry ranches are well-kept, highly-attractive establishments which are an asset trather than a liability to the community in which they reside, and this program is aimed at making this fact known to the general public as went as showing the way to uninformed poultrymen.


