



The new law applies to all candidates for nomination or election to public office, wheth-er he or she be a candidate for school board, city council, county board of supervisors, the Legislature, Congress, Gov-ernor, President of the United States, or any other public office.

untarity attacked in a smear sheet distributed shortly be-fore an election does not have time to take his attackers into court before the ballots are counted. Although he may win a libel action, he can lose an election if the readers of the smear sheet are foolish enough to believe last-minute attacks. Fortunately, most California voters are suspicious of candi-dates who fail to present their own cases but rely upon attack-ing their opponents a few days before a nelection.
