AN ORDINANCE OF THE CITY OF TORRANCE, CALIFORNIA, ORDERING CALLING, PROVIDING FOR AND GIVING NOTICE OF A SPECIAL ELECTION TO BE HELD IN THE CITY OF TORRANCE ON THE 25TH DAY OF OCTOBER, 1937, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF SAID CITY TWO PROPOSITIONS TO INCUR BONDED INDEBTEDNESS BY SAID CITY FOR CERTAIN MUNICIPAL IMPROVEMENTS.

WHEREAS, The City Council of the City of Torrance, California, did on the 17th day of September, 1937, by a vote of more than two-thirds of the members of said City Council adopt Resolution No. 328, entitled "RESOLUTION OF THE CITY COUNCIL OF TORRANCE, CALIFORNIA, DETERMINING THAT THE PUBLIC INTEREST AND NECESSITY DEMAND THE ACQUISITION AND CONSTRUCTION OF CERTAIN MUNICIPAL IMPROVEMENTS, AND MAKING FINDINGS RELATING THEREOF," which said resolution was duly signed and approved by the Mayor of said city and attested and certified by the City Clerk of said city.

Section 1. BOND PROPOSITION "B" - PARK AND RECREATION FACILITIES: The acquisition and construction by said city of a certain municipal improvement, to wit: additions to and improvements of the public airport of said city, including the acquisition and improvement of land for aircraft landing approach zones, runways, taxiways, and other airport facilities and improvements, together with all grading and the removal of buildings, and the acquisition of fencing, lighting, apparatus, equipment and property necessary for any of the foregoing.

BOND PROPOSITION "B" - PARK AND RECREATION FACILITIES: Shall the City of Torrance incur a bonded indebtedness in the principal amount of \$3,000,000 for the purpose of the acquisition and construction by said city of a certain municipal improvement, to wit: additions to and improvements of the public airport of said city, including the acquisition and improvement of land for aircraft landing approach zones, runways, taxiways, and other airport facilities and improvements, together with all grading and the removal of buildings, and the acquisition of fencing, lighting, apparatus, equipment and property necessary for any of the foregoing?

Section 5. A cross (+) placed in the voting square after the word "YES" in the manner hereinbefore provided shall be counted in favor of the adoption of a question or proposition. A cross (-) placed in the voting square after the word "NO" in the manner hereinbefore provided shall be counted against the adoption of a question or proposition.

Section 6. That for the purpose of holding said special election there shall be and hereby are established seventy-five (75) consolidated voting precincts, as said regular election precincts exist on the date of adoption of this ordinance, that the polling places for the respective precincts shall be the places hereinbefore designated; and that the persons heretofore named, being competent and qualified electors, are hereby appointed officers of election for their respective voting precincts and they shall hold said election and make return thereof in the manner provided by law.
