

Local Savings Firm Grows 115 Per Cent

A gain of 115 per cent in resources was registered by the Palos Verdes Federal Savings of Torrance during the 12-month period ending Sept. 30, Neill Davis, executive vice-president of the California Savings and Loan League, revealed.

Assets of the local institution now are \$3,781,841 which represents a gain of \$2,022,741 since Sept. 30, 1956.

Total resources of California savings associations now are over \$5-3/4 billion, Davis concluded.
