The law, at present, does not require that a person have insurance to drive in this State. Phe Vehicle Code, however, does require that the driver's feense and motor vehicle registration of any person who has failed to satisfy a final udgment rendered against alm as the driver of a motor vehicle involved in an accident or suspended until the judgment is satisfied to the extent required by law and until he furnishes proof of his financial responsibility to respond in damages in the future (Sec. 410).

A person may relieve himself of the suspension by filing with the Department of Motor Vehicles proof of vehicle liability insurance in such amounts as are required by law (Secs. 411.5 and 415). He may furnish proof of financial responsibility to the department by filing a vehicle liability policy or bond for the amounts required by law, deposit of a prescribed amount, or by filing a written certificate of self-insurer (Sec. 414).

THE VEHICLE Code also requires that the driver's license of the driver, and the vehicle registration of the owner, of a motor vehicle involved in an accident which has resulted in damage to the property of any or in bodily injury, or in the death of any person, be suspended unless an exemption from security is established or security in the amounts required by law is deposited with the Department of Motor Vehicles to satisfy any judgments that may result from the accident (Secs. 420, 421 and 424.1). A driver or owner may be exempt from the requirement of depositing security by filing with the department proof of 'ehicle liability insurance or bond for the amounts required by law or by filing a written certificate of self-insurer (Secs. 422, 422.4, 422.5).

TURNING TO the matter o constant increase in the rates for vehicle liability insurance, it might be pointed out that the Legislature has no direct control over the rates for such insurance. The rates are based upon the findings of licensed rating organizations that review and analyze the figures on accident costs, frequencies
