Board to Screen City Candidates

Creation of a special board composed of the city clerk, city attorney, and police chief to screen legal qualifications of candidates for city offices was ordered by the city council here Tuesday on the recommendation of City Attorney Stanley Remelmeyer.

Such a board would probably end the possibility of having candidates on the ballot who do not meet the legal requirements as a candidate, Remelmeyer said. At present, checking of a candidate's qualifications are left mostly to his opponents.
