Heavy run of yellowtail off the Coronado Islands and along the nearby Mexican coast still was hanging fire early this week although there were growing signs that the run was about to slide into high gear.

San Diego sportfishing boats took yellowtail in four different areas last weekend, showing that the schools are well scattered and heavier fishing pressure from both Point Loma and H. & M. fleets this week should turn up better catches. Saturday, North Coronado Island and Descanto Point proved the top producers although a few yellows were also bagged at the Rock Pile and in the flats between the Islands and Point Loma. Half day boats working near the Whistling Buoy just off the mouth of San Diego bay produced good catches of log barracuda and rock cod boats on the Nine Mile bank continued to account for full limits of 20 fish for nearly all hands.

ANGLING REGULATIONS

Except in 10 Northern Cali-fornia counties, the statewide trout limit for the general summer season during the next year will be 10 fish.
