

North American B-70s to Carry Name of 'Valkyrie'

The 2,000-mile-per-hour Air Force North American B-70 bomber has been named "Valkyrie" after maidens of great beauty who decided the outcome of battle in Norse mythology. The Strategic Air Command announced today.

The name was selected from 20,236 entries submitted in a contest among SAC officers and airmen at bases all over the world. The winner, T. Sgt. Francis W. Seiler, 39, formerly of New York, N. Y., is a photo interpreter for intelligence at March AFB. He will receive a \$500 U. S. Savings Bond and a three-day trip to Hollywood from North American Aviation, Inc., builders of the airplane.

Scheduled to replace the Boeing B-52 as this country's long-range strategic bomber.
