enlisted men's grade structure, Jordan now enters the new pay bracket designed to more exactly reflect the job level of responsibility which he holds. He retains the familiar first sergeant sleeve insignia, but is one grade higher than the former top master sergeant rank.

In effect since June 1, the new grade structure also allows for the rank of E-9 as the top enlisted men's grade. Jordan entered the Army in March, 1939, and completed basic training at Jefferson Barracks, Mo.
