

Chocolate Chip Chiffon Cake is Family Favorite

It's tradition in this family of fine cooks to start early. Mrs. King McFadden, 507 Amapola, today's guest cook, baked her first cake at the age of 10 and now her 16-month-old daughter, Kathy, is a busy helper in the kitchen. Mrs. McFadden chose as her favorite recipe to share with readers, a Chocolate Chip Chiffon Cake. She recalls her very first cake, a pink and white marble cake she baked for her mother's birthday. She was ten years old. This first cake was baked in a wood burning range on a farm in Iowa and Mrs. McFadden says "it might have been all right, if I had remembered to turn the pan around in the oven so that both sides would have equal heat."

The local couple are both members of the First Methodist church. Mrs. McFadden sings in the Chancel choir and is vice president of the Woman's Society of Christian Service. Kathy is an honorary baby member of the society. Besides her church work, Mrs. McFadden sews and bakes.

Mrs. McFadden, a graduate of Iowa State Teachers college and Bryan Memorial Hospital in Lincoln, Neb., has been night technician at the Torrance Memorial hospital for almost six years. Patients scheduled for early morning surgery remember her as "the man with the needle." He is a member of the Torrance Lions club.

This family's favorite cake recipe is listed here.

CHOCOLATE CHIP CHIFFON CAKE

- Sift together into mixing bowl:
 - 2-1/4 cups sifted cake flour
 - 1/2 tsp. baking powder
 - 3 tsp. baking powder
 - 1 tsp. salt
- Make a well in the dry mixture and add in order:
 - 1/2 cup salad oil
 - 5 egg yolks, unbeaten
 - 1/2 cup cold water
 - 2 tsp. vanilla
- Beat with a spoon until smooth. Measure into another large mixing bowl:
 - 1 cup egg whites
 - 1/2 tsp. cream of tartar.
- Whip together until whites form very stiff peaks. Pour egg yolk mixture gradually over beaten white, gently folding with rubber scraper until blended. Sprinkle over batter and fold in gently:
 - 3 oz. grated chocolate
- Pour into ungreased tube pan. Bake at 325 deg. and then at 350 deg. for 10 to 15 minutes. When the cake is done, invert pan immediately and let stand until cold.
