

### Nike Missiles To Be Displayed At Three Sites

At 3 a.m. the troops of Battery D will set up a nuclear-capable Nike-Hercules surface-to-air missile and a conventional Nike-Ajax in front of the Civic Auditorium at Cravens and El Prado Sts. The display will remain in Torrance until 10 a.m. From 10:30 a.m. to 1 p.m.

the display will be seen at the Palos Verdes Estates plaza in Palos Verdes Estates. The final display will be at Marineland, where the two Nike missiles will be located for the remainder of the afternoon.

The Nike-Hercules is the Army's newest surface-to-air missile; the first Hercules guarding the greater Los Angeles area went on site at Chatsworth on Aug. 29.
