

### Methodists To Attend Conference

Laymen and ministers of Torrance's three Methodist churches will attend the 109th session of the Methodist Church's Southern California-Arizona Conference opening tomorrow at the University of Redlands.

Local churches to be represented there include the First Methodist Church of Torrance, WALTERIA Community Church, and the Torrance Riviera Church.

At least 17 resolutions will be introduced on topics ranging from world peace to gambling, conference officials report.

One will urge the attorneys general of Arizona, Nevada and California to establish special commissions to combat newsstand smut.

Up for approval will be budgets totaling \$2.5 million. Bishop Gerald Kennedy, leader of the Los Angeles area, will preside.
