## Celebration Ends Tonight

Torrance's third annual Ranchero Days, which winds up its four-day run here this evening, is being hailed by community leaders as the best ever.

Opening Wednesday evening with midway concessions, mechanical rides, and a free wild animal show at frequent intervals, the celebration has attracted thousands of Southlanders to the grounds behind the city hall.

the rodeo yesterday afternoon, and a repeat performance scheduled for 2 p.m. today.

Scheduled to lead off last evening's parade was Lt. Gov. Glenn M. Anderson of Hawthorne, and a parade of early U. S. Flags carried by Scouts of the city. Following were some of the Southland's top parade horses, local float entries, and other attractions.

**TODAY'S** activities will get under way at 1 p.m. with the opening of the midway. The closing performances of the championship rodeo will be started at 2 p.m., and the free animal acts will be presented


at 2:30, 4:30, 7:30, and at 9:30 p.m.

Sponsored by the Chamber of Commerce and local service groups, the Ranchero Days celebration will provide funds for the city's entry in the Tournament of Roses in Pasadena next Jan. 1, and will provide funds for the philanthropic work of the clubs and organizations manning the midway concession stands.

**EVERYTHING** is available to the fair goer from dart games to pizza pie, and from snowcones to a roller coaster. Attendance at the celebration has been high and a large crowd was present for the first events at the rodeo yesterday afternoon.

## 17-Year-Old Girl Nabbed

Two men and a 17-year-old girl were held by Torrance police yesterday after their arrest here for possession of narcotics, and for suspicion of being under the influence of narcotics.

Delmar Leslie French, 19, of 4536 Narrot St.; Albert Tony Alameda, 20, 1323 W. 168th St., and the girl were arrested by Officers Charles Oates and Paul Singleton early Saturday at 174th St. and Prairie. The officers said they followed the car for several blocks trying to stop it after observing that it was being driven in an erratic manner.

**IN ADDITION** to being booked for possession and being under the influence of narcotics, Alameda, identified by officers as the driver, was booked on a charge of driving while under the influence of narcotics.

Unidentified pills and drugs were found by the officers and have been turned over to the Sheriff's narcotics bureau for laboratory testing. Police said both Alameda and French had been arrested several times previously on violation of narcotics laws.


