If you were "foreign born" and received your naturalization certifi cate, you must present this certificate at time of regis-tration. tration. The law requires that reg-

istration be in the Regis-trar's office, 808 North Spring Street, except where hardship cases restrict an ap-plicant from appearing here. In that event application for registration form must be made in writing and it must be filled out before a Notary Public, between August 10 and September 15.




