ANOTHER complex field in recommendation relates to searches and seizures by law enforcement official s. Our
state Constitution protects citi zens against unreasonable searches and seizures, and no warrant can be issued except on probable rause stated under
oath. Both The United State,
Supres Supreme Court and our California Supreme Court have clearly upheld this protection.
However, enforcement officers complain about the difficulties its strict application causes them in arresting and
convicting criminals, so sug. conviching criminals, so sug.
gestions have been made that
