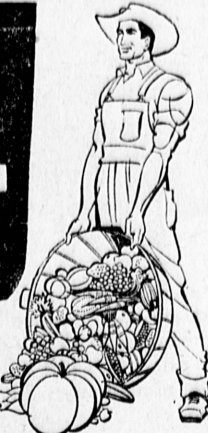

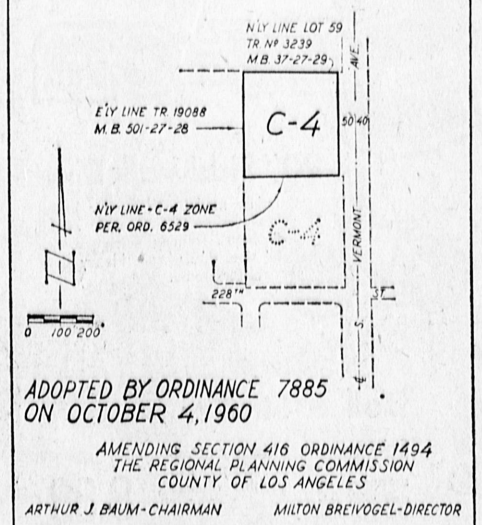

Sealed proposals will be received at the office of the State Highway Engineer, Room 406, Division of Highways Building, 129 South Spring Street, Los Angeles, California, until 2 o'clock p.m. on November 3, 1960, at which time they will be publicly opened and read in Room 2 of said building, for construction on the following project, in accordance with the specifications therefor, to which special reference is made, as follows:

Los Angeles County, on Figueroa Street at 228th Street and in Torrance on Hawthorne Avenue at Del Amo Boulevard (VII-1A-165, 164-A, Tor), traffic signal systems and highway lighting to be furnished and installed.

Bids are required for the entire work described herein. Plans, specifications, and proposal forms to be used for bidding on this project can be obtained at the office of the State Highway Engineer, Public Works Building, Sacramento, California.

Plans and specifications may be seen at the office of the State Highway Engineer, Sacramento, at the office of the District Engineer at Los Angeles and San Francisco, and at the office of the District Engineer of the district in which the work is situated.

No bid will be considered unless it is made on a blank form furnished by the State Highway Engineer and is made in accordance with the provisions of the Standard Specifications and special provisions. Each bidder must be licensed and also prequalified as required by law. The Department of Public Works reserves the right to reject any or all bids.

Employer payments other than those itemized herein, as defined in Section 1771.1 of the Labor Code, shall be made in accordance with the terms of the collective bargaining agreement applicable to the type or classification of the workmen or mechanics employed on the project.

Attention is directed to the fact that the Department of Industrial Relations, Division of Labor Statistics and Research, 1-1010 G of the Standard Specifications providing for employment of apprentices on the work. Every such apprentice shall be paid the standard wage paid to apprentices under the collective bargaining agreement applicable to the particular craft, classification or type of workman employed on the project.

Pursuant to the provisions of Section 1770 of the Labor Code of the State of California, the Department of Public Works has ascertained the general prevailing rate of wages and employer payments for health and welfare, vacation, pension and similar purposes in the county in which the work is to be done as follows:

NOTICE IS HEREBY GIVEN that sealed proposals for the purchase of \$2,000,000 par value general obligation bonds of Torrance Unified School District of Los Angeles County, California, will be received by the Board of Supervisors of said county at the place and up to the time below specified.

TIME: Tuesday, October 25, 1960 at 9:00 a.m.
PLACE: Office of the Board of Supervisors, 501 Hall of Records, Los Angeles, California.
MAILED BIDS: Board of Supervisors of Los Angeles County, Room 204, Hall of Records, Los Angeles, California.

ISSUE: \$2,000,000 consisting of 2,000 bonds numbered 1-2,000 both inclusive of the denomination of \$1,000 each, all dated November 1, 1960 and designated "Election 1968, Series E."

SIGNATURES: At least one of the signatures to the bonds shall be manually signed.

INTEREST: The bonds shall bear interest at a rate to be fixed upon the sale thereof but not to exceed 5% per annum, payable annually the first year and semiannually thereafter.

PAYMENT: Said bonds and the interest thereon are payable in lawful money of the United States at the office of the Treasurer of the County of Los Angeles, in the City of Los Angeles, or at any of the fiscal agencies of the county of Los Angeles, in the City of New York, State of New York, or in the City of Chicago, State of Illinois, at the option of the holders.

REGISTRATION: The bonds will be callable before maturity only as to both principal and interest.

SECURITY: Said bonds are general obligations of said unified school district, payable both principal and interest from ad valorem taxes which, under the laws now in force, may be levied without limitation as to rate or amount upon all of the taxable property, except certain personal property, in said unified school district.

TERMS OF SALE
Interest Rate: The maximum rate bid may not exceed 5% per annum, payable annually the first year and semiannually thereafter. The rate bid must be a multiple of 1/8%. No bidder shall bid more than one interest rate. No bond shall bear more than one interest rate.

Award: The bonds shall be sold for cash only. All bids must be for not less than all of the bonds hereby offered for sale and each bid shall state that the bidder offers par and accrued interest to the date of delivery, the premium, if any, and the interest rate to exceed that specified herein, at which the bidder offers to buy said bonds.

Each bidder shall state in his bid the total net interest cost in dollars and the average net interest rate determined thereby, which shall be considered informative only and not a part of the bid.

Highest Bidder: The bonds will be awarded to the highest responsible bidder or bidders considering the interest rate specified and the premium offered, if any. The highest bidder shall be determined by deducting the amount of the premium bid (if any) from the total amount of interest which would be required to be paid from the date of said bonds to the respective maturity dates thereof at the coupon rate specified in the bid and the award will be made on the basis of the lowest net interest cost to the district. The purchaser must pay accrued interest computed on a 360 day year basis, from the date of the bonds to the date of delivery.

The cost of printing the bonds will be borne by the district.

Right of Rejection: The Board of Supervisors reserves the right, in its discretion, to reject any and all bids and to extend the time for the receipt of bids, without any irregularity or informality in any bid.

Prompt Award: The Board of Supervisors will take action awarding the bonds or rejecting all bids not later than twenty-six hours after the expiration of the time herein prescribed for the receipt of proposals, provided that the award is made after the expiration of the specified time if the bidder should have given to said Board notice in writing of the withdrawal of such proposal.

Place of Bid: Each bid, together with the bid check, must be in sealed envelope, addressed to Board of Supervisors of Los Angeles County with the envelope and bid clearly marked "Proposal for Torrance Unified School District Bonds." Bid Check: A certified cashier's check on a responsible bank or trust company in the amount of 3% of the principal amount of the bonds, payable to the order of the County Treasurer, must accompany the bid. If successful, the bidder will accept and pay the check with the terms of his bid. The proceeds of the check accompanying any proposal accepted but not performed, unless such failure of performance shall be caused by any act or omission of the district, shall be returned to the bidder.

Change in Tax Exempt Status: At any time before the bonds are tendered for delivery the successful bidder may disaffirm and withdraw the proposal if the interest received by private holders from bonds of the same issue and character shall be declared to be taxable income under present federal income tax laws, either by a ruling of the Board of Internal Revenue or by a decision of any federal court, or shall be declared taxable by the terms of any federal income tax law enacted subsequent to the date of this notice.

No Litigation Certificate: At the time of payment for and delivery of said bonds the district will furnish the successful bidder a certificate that there is no litigation pending affecting the validity of the bonds.

Legal Opinion: A copy of the legal opinion of the attorney or firm of attorneys designated by the purchaser to the satisfaction of the Board of Supervisors or by his deputy, by his facsimile signature will be printed on the back of each bond at the expense of the successful bidder if requested in his bid.
