The compatibility of this complex age and an institution nearly two thousand years old provides the theme for the Redondo Beach Church of Christ's Annual Bible Lectureship, "The 20th Century Church," it was announced today.

Nine interesting and well-known ministers, educators, day concerning "20th Century Music." Dr. Sanders, professor of religion, was formerly Dean of David Lipscomb College, Nashville, Tenn., for 14 years. He attended Vanderbilt University, is a graduate of Texas Christian University, and received his doctorate at the University of

Monday evening, Dr. Howard A. White will lecture on "The Church and It's Past 20 Centuries." Dr. White is minister of the Westchester Church of Christ and College Department Head of Social Science. He attended David Lipscomb College and received his degree from Tulane University. Dr. White was a minister in the Southern States for many years.

"THE CHURCH and the Community" will be the topic for Mr. Donald M. Osborne's lecture on Tuesday evening, Osborne, formerly minister in Costa Mesa and Westminster, is now the minister of the Hermosa Beach Church of Christ. He has attended David Lipscomb and Wheaton Colleges, and is now engaged in post graduate work in addition to his regular ministerial duties.

Born in Japan, of missionary parents, and a resident of that country for 25 years, Dr. Logan Fox will speak Wednesday evening on "Sending the Gospel Abroad." Dr. Fox was a missionary in Japan for 12 years, having returned to this country early last year. President of Ibaraki Christian College in Japan, he is at present on leave of absence and serving as Associate Professor of Psychology at Pepperdine College.
