

Millinery Fashions Gaily Soar To New Heights, Mammoth Shapes

The Spring season calls for a 'hatter hat' with a stress on the bulky look — not heavy — but light!

One of the important silhouettes for spring 1960 is the BRETON; the innovation: the up-swept front. The newest version is banded about the crown with an upswing-ribbon.

There is a definite trend toward large full-blown BERETS worn to the back of the head or on profile. These are right for many of the suits and ready-to-wear with short, young jackets and skirts lightly gathered or rounded at the sides or for the Chanel-inspired ensembles.

HEIGHT is featured in tall pillboxes, turbans and toques which often telescope, and fezzes that keep to the back of the head are shown in many collections.

Ready-to-wear seems to demand this "high hat" silhouette because of the short bell sleeves cut just above the elbow featured in coats, suits and dresses. It gives perfect balance to the total look.

FABRICS There's a great use of hand-sewn braids which are lustrous and opalescent. This medium seems to be the perfect accompaniment for the white tones (banana, cream, ivory, etc.) endorsed by fashion-conscious women.

Novelty straw bandings are featured either sewn together, or for an airy effect, stitched on net, which gives a soft, light look to many of the fuller silhouettes.

Panama, ball - burl and a d strawhats are found in every line. There is an emphasis on texture both in hat bodies and novelty braids. For contrast there are the fine braids — seven milan for example, and novelty lace and light braids.

Fabrics emphasize geometric patterns with muted tones and flower prints. There are chiffons, stitched fabrics, crepes and silk jerseys.

Fabrics are truly whisper weight for spring and all are, of course, easy-care. Trims are luxurious and perfectly lovely under sheers.

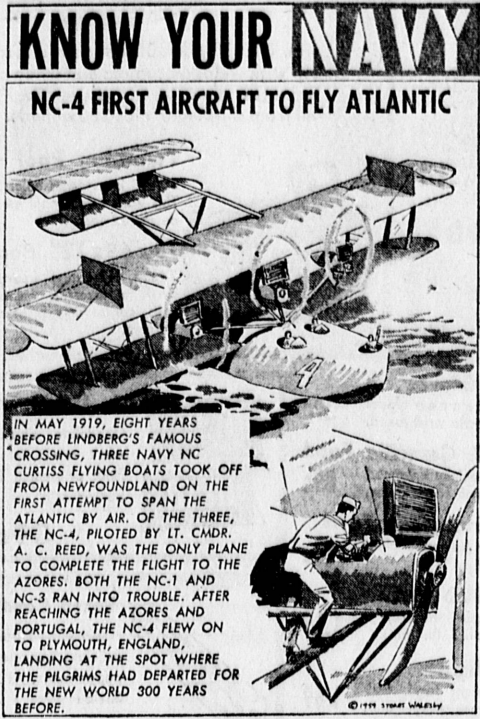
Colors — yes! — they return in lingerie, richer with more hues too. There is a color to match or contrast with every outfit in your wardrobe.
