Necessity Of Cancer **Exams Told**

October has been proclaimed October has been proclaimed by the Board of Supervisors as "Cancer Prevention Month" for the purpose of alerting all citizens to the importance of periodic cancer examinations. Supervisor Kenneth Hahn, author of the proclamation, pointed out that 17 persons die each day of cancer in Los Angeles County and that many

Angeles County and that many of them might have been saved if their illness had been detected early and promptly . . .

HE LAUDED the work of the Cancer Prevention Society of Los Angeles, a non-profit cor-poration, which operates a \$1,000,000 Cancer Detection Clinic at 303 S. Loma Drive, Los Angeles, and which has given 200,000 examinations to detect cancer over the past 18

years.

Superior Court Judge Roger Alton Pfaff, president of the Cancer Prevention Society, pointed out that the Cancer Detection Clinic had found 3.2 per cent of presumably well people had malignancies of which they were unaware.

"Many thousands of people are alive today and enjoying"

are alive today and enjoying good health and peace of mind because their malignancies

good health and peace of mind because their malignancies were detected and promptly treated and cured," he stated.

HAHN POINTED out that no charge is made for the examinations at the Cancer Detection Clinic, which relies entirely for its support on voluntary contributions to carry out its vital, life-saving work.

The dedicated officers, directors and medical staff of the clinic unselfishly contribute their time and talents in this work to alleviate human pain and suffering and to save lives," he declared.

In adopting the proclamation, the Board of Supervisors urged all citizens to give generous financial support to the work of the Cancer Prevention.
