

For April Election

Registration Ends For Voters Today

Today is the last day in which to qualify for the April 10 municipal election in Torrance, acting city clerk Gale Whitacre warned Torrance residents yesterday.

Registration is now in progress, and deputy registrars are on duty at their homes in their neighborhoods, and others are on duty each week day at the city hall, Whitacre said.

Those who must register or re-register are:

- Those who have changed their addresses since they last registered;
• Those who have changed their names since they last registered;
• Those who desire to change their political affiliation;
• THOSE VOTERS whose registrations were canceled because they did not vote at the General Election in 1960 and who have not re-registered since said cancellation.

Those who still reside at the same address and who sent in the return postcard mailed to them by the Registrar of Voters after the 1960 General Elec-

tion cancellation need not re-register.)

- Those who have become of age and have not registered.
• New residents of Los Angeles County who will have the required qualifications by the date of election.

THESE qualifications include:

- One year residence in the state;
• Ninety days residence in the county;
• Twenty-one years of age.
• An naturalized citizen must have been a citizen for at least 90 days prior to the date of the election and must show his naturalization papers to the deputy when registering for the first time.

All voters must be able to read the English language and sign their names, and must not be disqualified to vote by reason of a felony conviction. Information on location of deputy registrars in the various areas can be obtained from the city clerk's office at the city hall.
