AN ORDINANCE NO. 1309 OF THE CITY OF TORRANCE AMENDING SECTION 15.3 OF APPENDIX I OF THE CODE OF THE CITY OF TORRANCE, 1954* (OFFICIAL LAND USE ORDINANCE) GOV. CONCERNING THE SPLITTING OF LOTS.
The City Council of the City of Torrance does ordain as follows:
SECTION 1.
That Section 15.3 of Appendix I of "The Code of the City of Torrance, 1954* (Official Land Use Ordinance) is hereby repealed and the following provisions substituted therefor to read in their entirety as follows:
"15.3. Splitting lots. No lot or parcel of land shall be split or divided as provided in Articles I and II of Chapter 26 of this Code."
SECTION 2.
Any provision of the Torrance City Code, or appendices thereto, inconsistent herewith, to the extent of such inconsistency and no further, are hereby repealed.
SECTION 3.
This ordinance shall take effect thirty days from the date of its adoption and prior to the expiration thereof, the provisions of the ordinance shall be published at least once in the Torrance Herald, a semi-weekly newspaper of general circulation in Los Angeles County, California, on the 15th day of May, 1962.

AN ORDINANCE NO. 1310 OF THE CITY OF TORRANCE AMENDING SECTION 15.3 OF APPENDIX I OF THE CODE OF THE CITY OF TORRANCE, 1954* (OFFICIAL LAND USE ORDINANCE) GOV. CONCERNING THE SPLITTING OF LOTS AND BUILDING SITE AREA.
The City Council of the City of Torrance does ordain as follows:
SECTION 1.
That Section 15.3 of Appendix I of "The Code of the City of Torrance, 1954* (Official Land Use Ordinance) is hereby repealed and the following provisions substituted therefor to read in their entirety as follows:
"15.3. Splitting lots and building site area.
1. The requirements of this ordinance as to minimum lot area or building site area shall not be construed to prevent the use for dwellings or parcels of land, other than in the M-2 District, in which that such lot or parcel of land is:
(a) Shown separately on or hereafter upon any official subdivision map duly approved and recorded;
(b) Shown separately or hereafter upon any official subdivision map duly approved and recorded in accordance with the provisions of Article II of Chapter 26 of this Code; or
(c) Created by a deed recorded on or after January 1, 1952; and
(d) Greater in area than the minimum building site area of the lot or parcel of land in which such property is located."
2. No portion of any lot or parcel of land which has been designated as a minimum lot area or building site area as required by this Official Land Use Ordinance shall be included as a portion of an area or parcel of land which is a building site area if such inclusion will reduce the area or yard required for the original lot or parcel of land to less than the minimum building site area of the lot or parcel of land in which such property is located."
SECTION 2.
Any provision of the Torrance City Code, or appendices thereto, inconsistent herewith, to the extent of such inconsistency and no further, are hereby repealed.
SECTION 3.
This ordinance shall take effect fifteen days after the date of its adoption and prior to the expiration thereof shall be published at least once in the Torrance Herald, a semi-weekly newspaper of general circulation, published and circulated in the City of Torrance, California, on or after the 15th day of May, 1962.
