Water Level Expected to Remain Up

Levels in 23 of the county's etaoi etaoi etaoi tin h 30 ground water basins are expected to be higher as the result of heavy winter storms during the 1961-62 season, Supervisor Burton W. Chace disclosed yesterday.

At the same time, he said, levels are likely to be lower in only seven ground water basins this fall compared to 27 in the fall of 1961.

Recent statistics compiled by M. E. Salsbury, chief of County Flood Control District, reveal that the 1961-62 water year will be the first year since 1957-58 in which rainfall in Southern California will exceed normal.

FOR THE previous three years, it has been about 50 per cent of normal, Chace said.

Levels in the Signal Hill area will approximate the 1960 fall readings and will be higher than the historic low established last fall, it was reported.

Levels in the West Coast Basin will likely be about the same this fall as last.

SUPERVISOR CHACE said that ground water levels in the main San Gabriel basin rose rapidly last winter as a result of heavy snowfall and water conservation activities by the County Flood Control District.

Importance of ground water wells to Los Angeles County is pointed up by the fact that over 50 per cent of its daily supply is pumped from these sources, Supervisor Chace added.
