Partners in crime don't often Partners in crime don't often act like partners when caught: To protect themselves e a c h tries to push the blame on to others. They give evidence against one another. The self-confessed crimi-nal's evidence is not very re-liable. Le California when applied

liable. In California when an accomplice "sings" he must be corroborated. His word alone is not enough. The court demands other evidence.

At early common law a self-confessed felon could not tes-tify at all. Later he could, but tify at all. Later he could, out under suspicion. The judge usually warned the jury against such evidence as un-trustworthy. California law al-so calls for corroboration. Who are accomplices?

Who are accomplices? Anyone who had any role whatever in the crime: a go-between in a bribe case, the maker of a set of plans for a robbery or kidnaping, a per-son who takes narcotics from a pusher, a person who hires a killer or thief—anyone else who takes part in a crime such who takes part in a crime such

as the getaway man. The court asks for indepen-dent evidence to implicate the accused. Otherwise no conviction.

This rule aims at fair play at trials. Forced confessions are inadmissable as well as unreliable. They must be free and voluntary and not given under any pressure. The rule about accomplices


