

Plans Being Completed For Sabin Oral Sunday

County health officials and doctors are moving full speed ahead with plans for the Sabin Oral Sunday campaign against crippling polio.

The plan is to administer the Sabin vaccine, taken orally on a lump of sugar, to every resident of the six counties.

The project is a three-phase immunization program aimed at administering the Sabin Oral Vaccine to nearly 10,000, 600 residents of Southern California.

First phase of the crash program is slated for Oct. 21 and 22, with second and third dosages to be administered Dec. 2 and 9, and Jan. 20 and 27.

Neighborhood clinics within walking distance of every home in the six Southland counties will be set up for the program.

The Sabin vaccine is harmless, and is effective against all three known strains of paralytic polio.

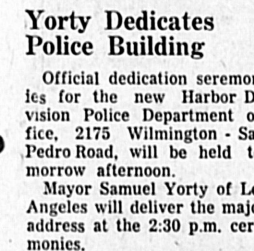
Miss Margaret G. Brant and Miss Joan A. Wilcox will join the newly established nursing department to work with Mrs. Cynthia Barnes.
