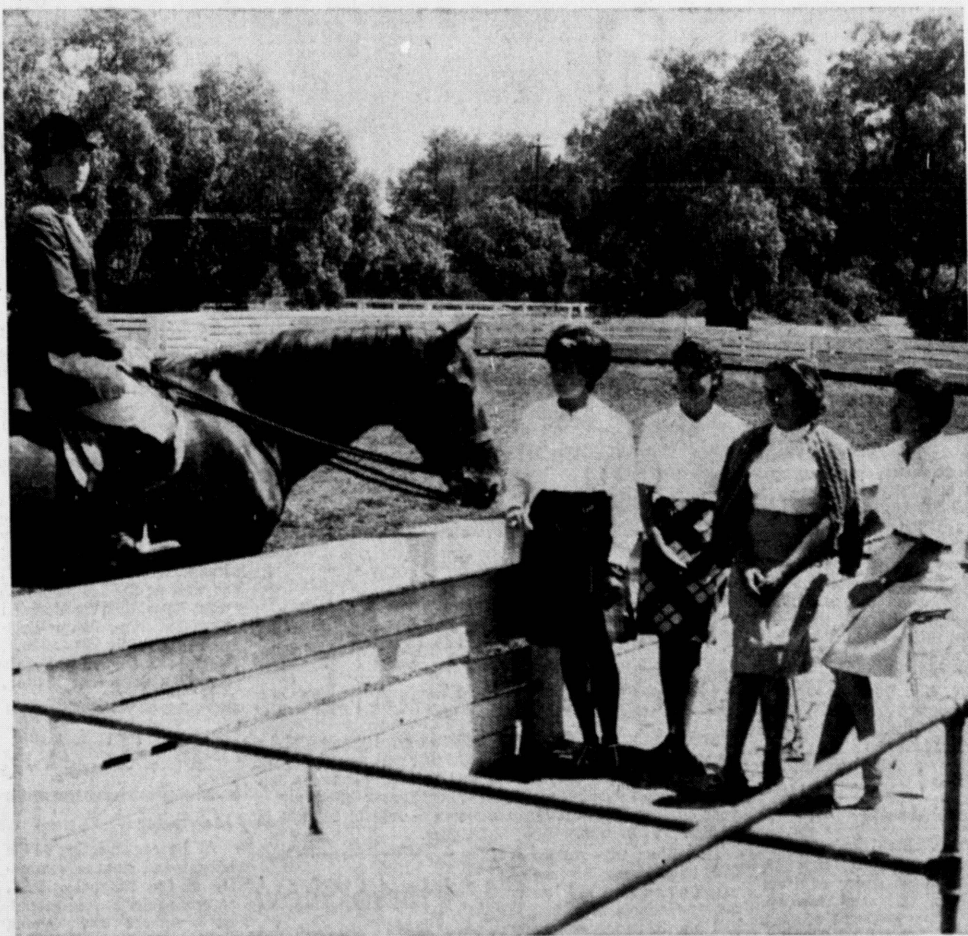

Festive "English County" Show Will Aid Hospital

Portuguese Bend National Horse Show, sponsored by the Palos Verdes Peninsula Committee of Childrens Hospital, will be held again this year at the Portuguese Bend Riding Club, Narcissa Drive in Portuguese Bend, Sept. 22 and 23. Proceeds from the event, which promises to surpass last year's show, acclaimed top show for the Pacific Coast Major circuit, will go to the building fund for Childrens Hospital. Mrs. Harry H. Wetzel Jr., chairman, has as co-chairmen, Mrs. Robert L. Prun and Mrs. Thomas M. Murphy.

The show, which attracted well over 10,000 persons last year, will have over 700 entries this year. An "English County Pony and Horse Show" will lend the theme for this presentation of top competition. In a setting, sim-

ilar in natural beauty, to the county shows in England, brightly colored awnings over the tiers of box seats and gala refreshment booths around the ring, will add festivity and color to the scene. Tables, under striped umbrellas on the turf around the ring, will seat guests for food and drink. A bugler, in

the traditional "pink" coat and high silk hat, will announce each event.

Allen Ross, manager of the Grand National Horse Show at Cow Palace in San Francisco, the Santa Barbara National Horse Show and others, will be the manager. Judges will be Robert H. Lewis, San Mateo, and Don Bent, Woodland Hills. ASHA steward, ringmaster, paddock steward and secretary will be Horace Rupp, Santa Barbara, Col. Alex Sysin, Stanford and Mr. and Mrs. Richard Glascock, Palos Verdes.

The All-Junior Show on Saturday will have three medal classes among the 18 classes competing.

The winners of the medal classes will be eligible to enter the final competition for the United States championships to be held later in the year at the Cow Palace and at Madison Square Gardens. Permanent silver trophies will be awarded to all winners. The Eli Vanderlip High-Point Perpetual Trophy will go to the junior exhibitor winning the highest points for the show.

Open Show Sunday will have nine stake classes competing, along with classes of hunters, jumpers and Shetland ponies. Perpetual trophies, along with permanent silver trophies, will go to the winners of all stake classes. Donors of the perpetual trophies and sponsors of the stake classes are Messrs. and Mmes. Robert L. Prun, Sam A. Simpson, John B. Kingsley, Hollywood Turf Club, Russell H. Green, Sr., Russell H. Green, Jr., Laurence A. Green, Robert Norman and Dede Norman; Lowell Dryden, Warren Burgess; Mrs. Robert McCulloch and the Palos Verdes Peninsula Committee of the Childrens Hospital, whose perpetual trophy will go to the winner of the Parade Horse class.
