TH-1044 ORDINANCE NO. 1327 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TORRANCE PERMITTING A TOTAL OUTSIDE WIDTH OF VEHICLE AND LOAD IN EXCESS OF THE LIMITS SET FORTH IN SECTION 35100 OF THE STATE VEHICLE CODE WHEN SUCH VEHICLE IS USED EXCLUSIVELY WITHIN THE BOUNDARY LIMITS OF THE CITY BUT LIMITING SUCH WIDTH TO 108 INCHES.

WHEREAS the Vehicle Code of the State of California specifies in Section 35100 certain permissible total outside width of vehicle and load...

WHEREAS, Section 35105 of said Code provides that any city organized under a freesholder's charter may by ordinance permit a total outside width of vehicle and load in excess of such limit...

SECTION 1. That Article VIII is hereby added to Chapter 17 of the Code of the City of Torrance 1964...

SECTION 2. Any provision of the Torrance City Code, or appendices thereto, inconsistent herewith...

SECTION 3. This ordinance shall take effect thirty days after the date of its adoption...
